## General Area of Cooperation

**3. NOW THEREFORE IT IS HEREBY AGREED BETWEEN THE PARTIES AS FOLLOWS in order to achieve the purpose:**

### 3. (a) RESPONSIBILITIES OF THE PARTY A

- Agrees to provide Green Audit in the CMRCET campus in various environment protection standards with the help of different experts.
- To facilitate details of pre-audit requirement to enhance the environment protection.
- It is responsible to provide the plan with design such that it accommodates changes based on information gathered during the audit and effective use of resources.
- To assess the strengths and weaknesses of the auditee's management controls and risks associated with their failure were established.
- To facilitate students to participate in regional, state, national events to enhance their experience.
- To analyze Air quality and biodiversity, water quality & usage, Energy consumption & costs, waste generation & disposal.
- Evaluate the audit evidence towards the objectives of Green audit and conduct exit meetings to discuss audit findings.

### 3. (b) RESPONSIBILITIES OF THE PARTY B

- Agrees to provide access to infrastructure for the Green Audit team to access related activities whenever required.
- Encourage the Green Audit team to organize awareness programs to staff & students towards Environment protection.
- The background information on the site's historical uses, the location of soiled and groundwater contamination was collected.
- Adopt necessary strategies and activities towards ensuring the sustainability of the environment protection.

## 4. Time Frame


This MOU will commence on 1<sup>st</sup> September 2014. The agreement will be automatically renewed further if both parties have no objection and the agreement can be altered/modify with the consent of both parties in writing whereas the need arise and situation demands.

(a) Parties to the AGREEMENT have expressly agreed to hold the entire information and documents related to this program as strictly confidential. Each Party


