REPORT ON ORIENTATION PROGRAM ON ANTI RAGGING

The Anti-Ragging Committee of CMR College of Engineering & Technology organized an Orientation **Program on the Anti-Ragging** on 18th September 2021 in CMR Auditorium.

The objective of the program was to educate students about the legal, ethical, and psychological implications of ragging and to promote a safe and inclusive academic environment.

The orientation program, organized by the CMRCET Anti-Ragging Committee, featured a guest lecture by A. Satyanarayana, Circle Inspector of Police, Police Station, Medchal. His presence underscored the seriousness with which CMRCET and the local law enforcement agencies view the issue of ragging. The program likely covered the following key areas:

- Welcome and Introduction:
 - The program commenced with an introduction by Dr.K. Vijaya Kumar, Coordinator of the Anti-Ragging Committee, who welcomed the new students and emphasized CMRCET's commitment to maintaining a ragging-free campus.
- Address by College Authorities:
 - Major Dr. VA Narayan, Principal spoke about the college's strict anti-ragging policies, reiterating that any act of ragging would be dealt with severely.
- Guest Lecture by A. Satyanarayana:
 - A. Satyanarayana, Circle Inspector of Police, Police Station, Medchal delivered a lecture focusing on the legal aspects of ragging. His talk included:
 - Explanation of the definition of ragging under the law.
 - Detailed information about the anti-ragging laws in India, including relevant sections of the IPC and other applicable legislation.
 - Emphasis on the criminal nature of ragging and the punishments prescribed for those found guilty, including imprisonment, fines, and expulsion from the institution.
 - Discussion of real-life cases and their consequences to illustrate the severity of the issue.
 - Information on how the police handle ragging complaints and the support they
 provide to victims.

- Reassurance to the students that the police and the college administration are committed to protecting them from ragging.
- CMRCET's Anti-Ragging Measures:
 - The Anti-Ragging Committee outlined the specific measures taken by CMRCET to prevent ragging, such as:
 - Constitution of the Anti-Ragging Committee and Anti-Ragging Squads.
 - Display of anti-ragging posters and notices at prominent locations on campus.
 - Undertakings from students and parents.
 - Regular monitoring of vulnerable areas, such as hostels, canteens, and common rooms.
 - Counselling services for both victims and perpetrators of ragging.
- Interactive Session:
 - The program included a Q&A session where students could interact with the Circle Inspector and members of the Anti-Ragging Committee to clarify their doubts and seek information.
- Information Dissemination:
 - pamphlets, brochures, and other materials containing important information about antiragging policies, laws, and contact details of relevant authorities are distributed.
