REPORT ON AWARENESS PROGRAM ON DRUG ABUSE, ILLICIT TRAFFICKING, AND ANTI-RAGGING ACT

An Awareness Program on Drug Abuse, Illicit Trafficking, and the Anti-Ragging Act was conducted at CMR College of Engineering & Technology on 8th November 2024. The event aimed to educate students on the dangers of drug abuse, the impact of illicit trafficking, and the significance of the Anti-Ragging Act. The program was attended by esteemed dignitaries, law enforcement officials, faculty members, and students.

The event was graced by key officials from the Telangana Anti Narcotics Bureau (TGANB) and local law enforcement, including:

Program Highlights:

The event commenced with a welcome address, followed by a seminar led by P. Sitaram, SP, TGANB, who discussed the devastating effects of drug abuse and the increasing threat posed by illicit drug trafficking. He elaborated on the psychological, social, and legal consequences of substance abuse.

Following his presentation, C. Harishchandra Reddy (DSP, TGANB), K. Subba Rami Reddy (DSP, TGANB), Srinivasa Rao (Inspector, TGANB), and G. Gopi (Inspector, TGANB) provided their insights into how drug trafficking networks operate and the role of law enforcement in preventing such activities. They emphasized the importance of community awareness and student vigilance in curbing drug-related crimes.

B. Srinivasa Reddy (ACP, Medchal) and A. Satyanarayana (CI & SHO, Medchal) spoke on the local law enforcement efforts to combat drug trafficking and how students can play an active role in reporting suspicious activities. Purushotham, Additional DCP, further reinforced the need for a collaborative approach between authorities and the public in addressing these issues.

Anti-Ragging Awareness:

Alongside discussions on drug abuse and illicit trafficking, students were also educated on the Anti-Ragging Act, 2009. The legal implications of ragging, the penalties involved, and the psychological impact on victims were highlighted. Students were encouraged to foster a culture of respect and inclusivity on campus.

The session concluded with a pledge taken by all students, committing to:

- Stay away from drugs and illicit substances.
- Report any suspicious drug-related activities to the authorities.
- Maintain a ragging-free campus and uphold respect for their peers.
