

Memorandum of Understanding (MoU)

This Memorandum of Understanding (MOU) outlines the terms and conditions of collaboration between "Student Tribe" and "CMRCET", hereinafter referred to as the "College."

Purpose:

College Side Deliverables:

In addition to the aforementioned offerings, the College agrees to provide the following support to the Student Tribe:

1. Point of Contact (POC): The College shall appoint a dedicated Point of Contact (POC) as soon as the MOU is signed to oversee all communications and ensure effective coordination between the College and the Student Tribe.

2. Support for Initiatives: The College shall extend support to the initiatives of the Student Tribe whenever feasible, including providing access to facilities, promoting events, and encouraging student participation.

Terms and Conditions:

1. This MOU is effective from the 4^{R} November 24 and shall remain in force until one year, unless terminated by either party with 30 days written notice.

2. The specific details and schedules of each partnership offering will be discussed and agreed upon separately through mutual consent in writing.

3. Both parties will collaborate in good faith, respecting each other's objectives and values.
