This Memorandum of Understanding (MoU) is made on 20-01-2025 between Swami Vivekananda University and CMR College of Engineering & Technology for cooperation witnesseth in academic exchanges, program development and research. This document establishes the guiding terms and principles of collaboration between the two organizations:

I. Legal Frameworks of both the Organizations:

Swami Vivekananda University, promoted by Regent Education and Research Foundation and conferred the status of a private university by Govt. of West Bengal (West Bengal Act XV of 2019) and approved by University Grants Commission (UGC) under Section 2 (f) of the UGC Act, 1956, having its campus at Telinipara, Barasat - Barrackpore Rd, Bara Kanthalia, West Bengal - 700121 represented by its Hon'ble Vice Chancellor Prof. (Dr.) Subrata Kumar Dey hereinafter referred to as the FIRST PARTY (which term or expression shall unless excluded by or repugnant to the context be deemed to mean and include its successor in office, representatives, administrators, and assigns).

CMR College of Engineering & Technology, is an undergraduate college & postgraduate college affiliated to the JNTU Hyderabad established in 2002, located at Kandlakoya(V), Medchal Road, Hyderabad -501 401, and represented by Major Dr V A Narayana, Director, here in after referred to as the second party (which term or expression shall unless excluded by or repugnant to the context be deemed to mean and include its successor in office, representatives, administrators, and assigns).

Both these organizations will be hereafter referred to as parties.

II. Purpose of the Agreement:

Both the Parties are pleased to enter upon an agreement to establish ties of academic cooperation in order to contribute to the achievement of their overall goals as institutions through following but not limited to:

1. Student and faculty exchange programs.
2. Collaboration in the area of academic publications, research activities, field trips etc.
3. Visits, training and expert lectures by faculties of both institutions in exchange for benefit of staff and students.
4. Co-hosting and participation in conferences, seminars, symposiums and workshops.
5. Social and cultural programs.
6. Student visits for access of laboratories.
7. Pool campus participation.
8. Joint student internship.
9. Any other activity that is mutually agreed upon and is beneficial to both.

III. Execution of the Agreement:

The specific activities to be carried out under this agreement will be stated in corresponding specific sub-agreements. Such specific sub-agreements, once approved by both parties, will be attached as annexes to this agreement.

The specific sub-agreements between both Parties will specify their objectives, conditions and ways of execution, financial support, period the sub-agreement will be in effect, and administrative responsibility within each institution.

IV. Duration and Termination


- a. This MoU will be in effect for a period of 5 years from the date of its signing unless terminated by mutual written agreement or due to unforeseen circumstances.
- b. Either party may terminate this MoU with written notice of 1 month in advance.

V. Non-Exclusivity:

This Agreement is a non-exclusive agreement, and both parties remain free to enter into similar agreements with third parties.

VI. Special Provisions:

1. Each party will take approval from the other party in writing prior to

2. All parties hereto shall do their utmost to ensure the smooth and efficient implementation of the programs.
3. The parties will consult with each other for any subsequent associated agreement informally and attempt to resolve disputes or misunderstandings that may arise in the administration of this MoU or any subsequent associated agreement informally.
4. Neither party can misuse this MoU by involving the name of the other without the written consent from the other party.
5. There will be no financial involvement by either of the party.


