### **Sub: CMRCET-Exam Branch- M.Tech Course – Fee payment details and Procedure for Evaluation of Project Thesis (Viva –Voce Exam)– Reg.**

In connection with Project Viva-Voce Examinations to be conducted for M.Tech students admitted in the academic year **2022-23 & 2021-22 (Supplementary)** are hereby informed that the following procedure is to be followed for the submission of project thesis:

1. The student is permitted to submit project thesis only after successful completion of theory and Practical courses.
2. The eligible students can submit their thesis and filled application form to the M.Tech coordinator/HoD on or before **21.01.2025**.  
The concerned project coordinators are requested to submit the filled application form of the students with recommendation of supervisor and HOD on or before **22.01.2025** to the Controller of Examinations.
3. The students can pay the Project viva voce fee (including plagiarism checking fee) from **23.01.2025 to 30.01.2025** through online after approval from the concerned M.Tech coordinator and HOD. Fee is to be paid online through:

(a) <https://dhondi.cmrct.ac.in> (or) Student mobile App for R22 Regulation.

(b) <https://www.cmrctexaminations.com/BEESERP/Login.aspx> for R18 Regulation.

4. No penalty will be levied to the student if a student submits Thesis / Dissertation within one calendar year after completion of penultimate semester (i.e. within 6 months from the last semester). If the student is unable to submit the project within one calendar year, a penalty of Rs. 6000 will be levied for the first year of late submission, Rs. 13000 will be levied for the second year of late submission.
