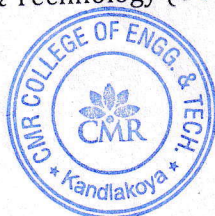
**Item 3:** Approval for the Academic Calendars of B.Tech III and IV Years of AY 2022-23.

Chairman has presented the Course Structure and syllabus of B.Tech- AIDS, AIML & CSE(Data Science), II Year (R18 Regulations) and B.Tech- CSE(AIML) & CSE(Cyber Security), III & IV Year courses structure & syllabus (R18 Regulations) along with the minutes of Board of Studies.

**Resolution:** The committee has reviewed and approved the B.Tech- AIDS, AIML & CSE(Data Science), II Year courses structure & syllabus of R18 Regulations and B.Tech- CSE(AIML) & CSE(Cyber Security), III & IV Years courses structure & syllabus of R18 Regulations (**Attached as Annexure-4**).

**Item 5:** Review & approval of Project Phase –II registration eligibility condition modification in R18 Regulations.

Chairman has presented the R18 Regulation Clause 9.10(d) regarding Project Phase-II registration “For the registration of Project Phase-II the student must have passed Project Phase-I”. The chairman also presented and explained clearly the consequences of this clause in implementation.

**Resolution:** The Committee has reviewed and approved that the students need not register once again for the Project Phase-II in IV-II, as they have already registered for Project Phase-I in IV-I. But the students are required to pass in project phase-I to be eligible for project phase-II External Evaluation.

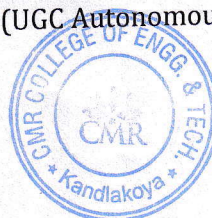
**Item 6:** Review & Approval of permission for

After receiving the guidelines from University, the R22 Academic Rules & Regulations may be discussed.

**Item 10:** Seeking suggestions on Attendance based detention for A.Y 2021-22 even semester

Chairman apprised to the committee that with reference to university order **Lr. No. JNTUHEB/COVID Exemption/2022, dt: 05-01-2022** students have been exempted from detention based on attendance for the odd semester of A. Y 2021-22, however the chairman has asked for exemption on attendance based detention for even semester of A.Y 2021-22.

**Resolution:** Committee has advised to follow the University direction for the attendance based detention. If the University does not give any directions, then follow academic regulations in respect of attendance based detention for the current semester of A.Y 2021-22 and same has to be implemented.
