- 1) B.Tech-Civil Engineering- from 30 to 60 seats
- 2) B.Tech- EEE – from 30 to 60 seats
- 3) B.Tech- Mechanical Engineering – from 30 to 60 seats
- 4) B.Tech- ECE – from 120 to 180 seats
- 5) B.Tech - CSE – from 750 to 540 seats
- 6) B.Tech - CSE (AI & ML) – from 360 to 480 seats
- 7) M.Tech - Structural Engineering – from 12 to 18 seats
- 8) M.Tech - Embedded Systems – from 12 to 18 seats
- 9) M.Tech - Computer Science & Engineering – from 12 to 18 seats
